MATTERS ARISING FROM THE MINUTES

MINUTE 1/2016 - COVENTRY HALF MARATHON - SUNDAY, 28TH FEBRUARY 2016

Members discussed the arrangements for the half marathon which had been held the previous day.

RESOLVED: that the issue of roads being closed early by Stewards before barricades were put up, also no communication made to local residents in Ted Pitts Lane or Wall Hill Road about the route be raised with the Event Organiser.

MINUTE 56/2015 - WALC - TRANSPARENCY FUND

The Clerk confirmed that she had submitted an application to WALC for funding for equipment to comply with the Transparency Act.

MINUTE 12/2016 – CASUAL VACANCY

Members noted that a casual vacancy has arisen following the resignation of Cllr Deakin and that Notice of the Vacancy would be given and if no request for a by election is given in accordance with the statutory process, the Parish Council can seek to fill the vacancy by co-option.

Members noted that a complaint had been received on behalf of horseriders using Wall Hill Road,that the recently resurfaced road was a slipping hazard for horses. The Clerk had raised this with the Highway Authority and post treatment work had been undertaken to the recently resurfaced road as a matter of urgency.

MINUTE 52/2015 - NEIGHBOURHOOD PLAN

Cllrs Farrar and Burton reported on themeeting they had attended with the Planning Consultant together with the Clerk. Members considered the quotations for consultancy services for preparation of a Neighbourhood Plan.
